Being a parcel of land lying on the left side of the existing centerline of right-of-way of Hudson Street (60' R/W – Public) and being more particularly described as follows:

COMMENCING FOR REFERENCE at a 1" iron pin set in a monument box on at an angle point in the centerline of right-of-way of Hudson Street, being the southeast corner of Lot 5 of the Partition of Casper Kiner's Heirs as recorded in Deed Book volume 326, page 464, the southwest corner of Highway Park Extension as recorded in Plat Book volume 17, page 354, and being on the northerly line of Grasmere Gardens as recorded in Plat Book volume 15, page 2, said pin being at station 61+45.69 of the said centerline of right-of-way of Hudson Street;

Thence along the Grantor's southerly line, the southerly line of the said Lot 21, and the said existing northerly right-of-way line of Hudson Street, **North 86 degrees 36 minutes 37 seconds West for a distance of 7.46 feet** to a point being 30.00 feet left of the centerline of right-of-way of Hudson Street station 72+10.83;

Thence crossing through the lands of the Grantor and through the said Lot 21, North 36 degrees 22 minutes 31 seconds East for a distance of 13.81 feet to a point on the Grantor's easterly line, the easterly line of the said Lot 21, and on the said westerly right-of-way line of Medina Avenue, said point being 41.59 feet left of the centerline of right-of-way of Hudson Street station 72+18.34;
