Situated in the State of Ohio, County of Franklin, City of Columbus, Clinton Township, being in Quarter Township 4, Township 1 North, Range 18 West of the United States Military Lands, being part of Lot 22 of Homestead Heights as recorded in Plat Book volume 15, page 7 (all document references are to the records of Franklin County unless otherwise stated), and being a 0.002 acre parcel out of that tract known as Franklin County Auditor's **Parcel Number 010-075360** as conveyed to **Vivian C. Jamison** (hereafter referred to as "Grantor") by the instruments filed as **Instrument Number 200710150179860** and **Deed Book volume 2924, page 229.** 

Being a parcel of land lying on the right side of the existing centerline of right-of-way of Hudson Street (60' R/W – Public) and being more particularly described as follows:

**COMMENCING FOR REFERENCE** at a 1" iron pin set in a monument box on at an angle point in the centerline of right-of-way of Hudson Street, being the southeast corner of Lot 5 of the Partition of Casper Kiner's Heirs as recorded in Deed Book volume 326, page 464, the southwest corner of Highway Park Extension as recorded in Plat Book volume 17, page 354, and being on the northerly line of Grasmere Gardens as recorded in Plat Book volume 15, page 2, said pin being at station 61+45.69 of the said centerline of right-of-way of Hudson Street;

Thence along the said centerline of right-of-way of Hudson Street, **South 86 degrees 36 minutes 37 seconds East for a distance of 1121.37 feet** to a point being at station 72+67.06 of the centerline of right-of-way of Hudson Street;

Thence leaving the centerline of right-of-way of Hudson Street perpendicularly, **South 03** degrees 23 minutes 23 seconds West for a distance of 30.00 feet to a point at the Grantor's northwest corner, the northwest corner of the said Lot 22, and being at the intersection of the existing southerly right-of-way line of Hudson Street and the easterly right-of-way line of Medina Avenue (50' R/W – Public), said point being 30.00 feet right of the centerline of right-of-way of Hudson Street station 72+67.06, said point being the **TRUE POINT OF BEGINNING** of the parcel herein described;

Thence along the Grantor's northerly line, the northerly line of the said Lot 22, and the said existing southerly right-of-way line of Hudson Street, **South 86 degrees 36 minutes 37 seconds East for a distance of 13.48 feet** to a point being 30.00 feet right of the centerline of right-of-way of Hudson Street station 72+80.54;

Thence crossing through the lands of the Grantor and through the said Lot 22, South 57 degrees 29 minutes 25 seconds West for a distance of 16.64 feet to a point on the Grantor's westerly line, the westerly line of the said Lot 22, and on the said easterly right-of-way line of Medina Avenue, said point being 39.76 feet right of the centerline of right-of-way of Hudson Street station 72+67.06;

Thence along the Grantor's westerly line, the said westerly line of Lot 22, and the said easterly right-of-way line of Medina Avenue, North 03 degrees 22 minutes 44 seconds East for a distance of 9.76 feet to the TRUE POINT OF BEGINNING of the parcel herein described.
