Thence along the said easterly line of the Grantor, the said easterly line of Lot 44, the said westerly line of Lot 45, and the said westerly line of the Goldman Properties, LTD., an Ohio Limited Liability Company tract, **South 03 degrees 29 minutes 33 seconds West for a distance of 13.00 feet** to a point at the southeast corner of the Grantor, the southeast corner of the said Lot 44, the southwest corner of the said Lot 45, the southwest corner of the said Goldman Properties, LTD., an Ohio Limited Liability Company tract, and on the said existing northerly right-of-way line of Hudson Street, said point being 30.00 feet left of the centerline of right-of-way of Hudson Street station 82+49.21;

Thence along the Grantor's southerly line, the southerly line of the said Lots 44 & 43, and the said existing northerly right-of-way line of Hudson Street, North 86 degrees 11 minutes 03 seconds West for a distance of 80.77 feet to the TRUE POINT OF BEGINNING of the parcel herein described.
