BEGINNING at a point (being referenced by a ¾" iron pipe found bearing North 05 degrees 23 minutes 14 seconds West a distance of 1.71 feet), said point being at the northwest corner of the Grantor, at the northwest corner of the said Lot 14, on the existing southerly right-of-way line of Hudson Street, at the northeast corner of Lot 15 of the said Maple View, and at the northeast corner of that tract as conveyed to Della Johnson by the instruments filed as Official Record volume 14383, page D15 and Official Record volume 14383, page D12, said point being 30.00 feet right of the centerline of right-of-way of Hudson Street station 88+80.57, said point being the **TRUE POINT OF BEGINNING** of the parcel herein described;
