#### 5. <u>A description of work performed to date as part of the contract and a full description of</u> work to be performed during any future phasing of the contract.

Work performed to date includes both design and construction phase construction management (CM) services for multiple capital improvement projects including: program management, constructability reviews, construction cost estimating, project coordination, construction scheduling, construction administration, construction administration, administration, administration, services, etc.

This renewal provides funding for construction phase CM services including program management, construction management, field representation/inspection, material inspection and testing, PLC programming and controls integration services, O&M ready support services, assistance with claims negotiation, and other related services. These services will be provided through the end of each construction project included in the PCM program. Work to be performed under future renewals will consist of CM services.

# 6. <u>An updated contract timeline to contract completion.</u>

This contract provides Professional Construction Management (CM) services under multiple contract modifications over a multiyear period to support multiple construction projects that begin construction within the 2017 through 2020 period, with services extending through the end of the construction durations for each assigned project. Current project schedule estimate calls for a contract completion date in 2022, but this contract duration may need to be extended based on actual construction durations.

The original contract was executed in March 2016 to allow the Professional Construction Management Team to perform design phase CM services for four projects (the DRWP Standby Power Project, the HCWP Standby Power Projects, the DRWP UV Disinfection Project, and the HCWP UV Disinfection Project).

Contract modification #1 provided funding for design phase CM services for six projects (DRWP and HCWP Standby Power Projects, DRWP and HCWP UV Disinfection Projects, the HCWP Hypochlorite Conversion Project, and the PAWP Hypochlorite Conversion Project) and construction phase services for three projects (DRWP and HCWP Standby Power Projects and the DRWP UV Disinfection Project).

Contract modification #2 provided funding for design and construction phase services for the six projects listed above under mod #1, plus design and construction phases services for the APCS Miscellaneous Improvements project (690441-100002) and design phase services for the HCWP Basin Concrete Improvements project (690389-0).

Contract modification #3 provided funding for design or construction phase services for the DRWP and HCWP Standby Power Projects, the DRWP and HCWP UV Disinfection Projects, the APCS Miscellaneous Improvements project, and the PCM II Project (690553-100000).

Contract modification #4 provided funding for construction phase services for the DRWP and HCWP Standby Power Projects, the DRWP and HCWP UV Disinfection Projects, the APCS Miscellaneous Improvements project, and the PCM II Project (690553-100000).

Contract modification #5 (current) will provide funding for construction phase services for the DRWP and HCWP Standby Power Projects and the DRWP and HCWP UV Disinfection Projects, and the PCM II Project (690553-100000).

Future contract modifications for Professional Construction Management services will be requested to continue PCM services through closeout of the last construction contract.

This is a Professional Construction Management project which will facilitate the construction administration and construction inspection services for projects in the Division of Water capital program. These projects are all related to the drinking water supply and treatment systems. These projects are incorporated in the capital improvement program for various reasons including meeting regulatory requirements, improving the reliability of the City's drinking water supply, and enhancing worked and public safety. All of these functions are tied to the economic vitality of the service area.

The consultant team has identified a commitment to the Mayor's Green Initiative in their business practices, including recycling programs in their offices, a commitment to double sided printing, and utilization of Project Management Information System (PMIS) for submittal reviews which limits the need for printing documents for review.

8. <u>A description of any and all modifications to date including the amounts of each modification and the Contract Number associated with any modification to date. (List each modification separately.)</u>

The Original Contracts (PO003180, PO003188, PO003196, PO003199, PO003202, PO003205, PO003208); Ordinance #0003-2016) were executed in March 2016 in the amount of \$618,000.00.

Contract Modification No. 1, under PO049895, in the amount of \$1,506,000.00, provided funding for construction management services for the March 2017 through February 2018 period.

Contract Modification No. 2, under PO098486, in the amount of \$5,069,000.00, provided funding for construction management services for the March 2018 through February 2019 period.

Contract Modification No. 3, in the amount of \$7,576,000.00, provided funding for construction management services for the March 2019 through February 2020 period.

Contract modification #4, for the amount of \$3,998,000, provides funding for construction management services for the March 2020 through November 2020 period.

Contract modification #5 (this legislation), for the amount of \$2,878,000, provides funding for construction management services for the December 2020 through November 2021 period.

Future contract modification requests to continue funding for the duration of this multi-year contract will be submitted as summarized in item 12 below.

This contract modification provides Professional Construction Management (PCM) services for the capital improvements projects listed below. Additional projects or services may be added to the PCM program as needed and approved by City council. The work to be performed under this contract modification includes construction phase CM services as described in Item 5 above for the projects identified below:

**Project 690486-100000 HCWP Hypochlorite Conversion** No work under this contract renewal.

**Project 690487-10000 PAWP Hypochlorite Conversion** No work under this contract renewal.

# Project 690519-10000 HCWP Standby Power

This project will provide a standby power system at HCWP consisting of multiple onsite diesel standby generators, associated switchgear, etc. The standby power system will allow the City to continue to treat and distribute water during an extended, area wide power outage.

#### Project 690520-100000 DRWP Standby Power

This project will provide a standby power system at DRWP consisting of multiple onsite diesel standby generators, associated switchgear, etc. The standby power system will allow the City to continue to treat and distribute water during an extended, area wide power outage.

# Project 690535-100000 DRWP UV Disinfection

This project will add UV disinfection capability at the DRWP. The UV system will provide an additional microbial treatment barrier and significantly enhance public health protection.

# Project 690536-100000 HCWP UV Disinfection

This project will add UV disinfection capability at the HCWP. The UV system will provide an additional microbial treatment barrier and significantly enhance public health protection.

**Project 690441-100002 ACPS Miscellaneous Improvements** No work under this contract renewal.

# Project 690389-100000 HCWP Basin Concrete Rehabilitation

No work under this contract renewal.

The original RFP and the initial authorizing legislation Ord. 0003-2016 for this project anticipated that the selected PCM team would provide services over a multi-year period to maintain continuity and consistency through the project construction periods and to provide coordination between projects. The current PCM team is familiar with the details of the multiple construction projects underway. The process of selecting and contracting a new PCM team to oversee these construction projects would likely impact construction progress and increase construction costs.
