The following investigation was conducted concerning the City of Columbus' 2019 annual objection to the renewal of liquor permit 6367760 issued to NEDAA LLC, which is doing business as Sunoco located at 2281 Sullivant Avenue, Columbus, Ohio 43223. The recorded owner of said permit is Nafez Jallaq.

After reviewing the State of Ohio, Franklin County, and City of Columbus records regarding the above liquor permit establishment, the following information has been compiled to support the objection to the renewal of the aforementioned permit issued by the State of Ohio.

The above listed liquor establishment has been issued a **C1 and C2** permits by the Division of Liquor. This permit grants the permit holder the privilege to sell alcoholic beverages at the above listed address.

A review of the Columbus Division of Police records revealed the Division of Police has created (73) seventy-three official police reports concerning incidents at the listed liquor establishment between January 2019 and November 2020. These reports referenced homicide, shots fired, rape, robberies, drug trafficking and possession, assaults, loitering with possible solicitation, accidental overdoses, intoxicated persons needing assistance, recoveries of stolen vehicles, motor vehicle theft, and tobacco violations, including:
