The recorded owner of said permit is **Muhammad Ashraf**.

After reviewing the State of Ohio, Franklin County, and City of Columbus records regarding the above liquor permit establishment, the following information has been compiled to support the objection to the renewal of the aforementioned permit issued by the State of Ohio.

The above listed liquor establishment has been issued a **C1** permit by the Division of Liquor. This permit grants the permit holder the privilege to sell alcoholic beverages at the above listed address.

An inquiry of liquor violations revealed that the permit holder has received the following violation in **2019** that are still pending in **2020**:
