Sir,

The following investigation was conducted concerning the City of Columbus' 2019 annual objection to the renewal of liquor permit **41801750002** issued to **J MAC Investments LLC.**, which is doing business as **Moments Grill and Lounge** located at **2545 Petzinger Road, Columbus, Ohio 43209**. The recorded owner of said permit is **Tammy Scott**.

After reviewing the State of Ohio, Franklin County, and City of Columbus records regarding the above liquor permit establishment, the following information has been compiled to support the objection to the renewal of the aforementioned permit issued by the State of Ohio.

The above listed liquor establishment has been issued a **C1** permit by the Division of Liquor. This permit grants the permit holder the privilege to sell alcoholic beverages at the above listed address.

An inquiry of liquor violations revealed that the permit holder has received the following violation in **2020**:

PERMIT NOT POSTED IN CONSPICUOUS PLACE

A review of the Columbus Division of Police records revealed the Division of Police has created **(41) forty-one** official police reports concerning incidents at the listed liquor establishment between **January 2019** and **November 2020**. In addition, the Columbus Division of Police have been dispatched to **2545 Petzinger Road, Columbus Ohio 43209** on **(112) one hundred twelve** calls for service, **(49) forty-nine** in 2019, and **(63) sixty-three** in 2020 at **Moments**. These calls for service include responses to shootings, shots fired, stabbing, persons with guns, fights and disturbances, domestic disputes, and noise complaints.
