<u>SUPPLEMENTED EXHIBIT C-2</u> <u>PUBLIC INFRASTRUCTURE IMPROVEMENTS</u>

The Public Infrastructure Improvements include but are not limited to any of the following improvements that will directly benefit the TIF parcels, together with all related costs of those permanent improvements (including, but not limited to, those costs listed in Section 133.15(B) of the Ohio Revised Code):

Thompson Road

- widening of Thompson Road from a point approximately 550' east of Hamilton Road to the bridge over Rocky Fork Creek;
- Thompson Road bridge replacement over Rocky Fork Creek;

Morse Road

- widening of Morse Road from Hamilton Road to the US 62/Morse Road roundabout improvements;
- US 62/Morse Road roundabout enhancements;

Central College Road

- Replacement and widening of Central College Road from Lee-Ulry Road to a point approximately 1600' east of Harlem Road;
- Central College offsite storm sewer from Sandimark Place to Lee-Ulry Road;
- Improvements to Central College Road and Lee-Ulry Road intersection;

<u>Bikepath</u>

- 10' bike path from a point on Dublin-Granville Road approximately 800' feet west of Harlem Road to Thompson Road with a bridge over Rocky Fork Creek;
- bike path and bike path culvert under Thompson Road;
- 10' bike path from Thompson Road to bike path at The Ridge at Chestnut Hill;

Hamilton Road

- reconstruction of Hamilton Road from a point approximately 550' north of Morse Road to start of relocated Hamilton Road;
- relocation of Hamilton Road from a point approximately 2100' south of Dublin- Granville Road on existing Hamilton Road to Dublin-Granville Road;
- widening and reconstruction of Hamilton Road from Dublin-Granville Road to Central College Road;
- construction of Hamilton Road from Central College Road to Walnut Street;
- State Route 161 expressway exit ramps;

Dublin-Granville Road

- widening and reconstruction of Dublin-Granville Road from existing Hamilton Road to relocated Hamilton Road;
- addition of turn lanes, intersection sight improvements and other intersection improvements to intersection of Dublin-Granville Road and relocated Hamilton Road;

Other Projects

- widening of Harlem Road from 400' north of Central College Road to 550' south of Central College Road;
- intersection improvement to Harlem Road and Central College Road intersection;
- relocation of Harlem Road at intersection of Harlem Road and future Hamilton Road extension to Walnut Street;
- replacement of Warner Road from Lee-Ulry Road to a point 900' east of Hamilton Road;
- widening of and overlay to Dublin-Granville Road from 700' west of existing Hamilton Road to 2000' east of relocated Hamilton Road;
- Preserve Crossing Blvd. from Morse Road to Thompson Road;

including, in each case, constructing and installing curbs and gutters, medians, public utilities which include water mains, sanitary sewer, and storm sewer, stormwater improvements, burial of utility lines, gas, electric and communications service facilities (including fiber optics), street lighting and signs, sidewalks, bikeways, and landscaping (including scenic fencing and irrigation), traffic signs and signalization, and including design and other related costs, any right-of-way or real estate acquisition, erosion and sediment control measures, grading, drainage and other related work, survey work, soil engineering, inspection fees and construction staking, and all other costs and improvements necessary and appurtenant thereto.

Supplements to Exhibit C – Public Infrastructure Improvements

All projects above were originally included in "Exhibit C – Public Infrastructure Improvements" designated by Ord. 2117-2005 and were reaffirmed and remained a part of "Supplemented Exhibit C Public Infrastructure Improvements" pursuant to Ord. 0715-2009. In addition to these above, the following types of improvements indicated below, as well as certain specific projects indicated below, were added as supplements to the original list by Ord. 0715-2009.

- 1. Pedestrian and bicycle facilities, and/or multi-use paths, such as, but not limited to, the following:
 - Harlem Road from Dublin-Granville Road to Walnut Street widen shoulders to accommodate bicycle travel
 - Warner Road from west of Harlem to Harlem continue sidewalk/multi-use path from the west
 - Ulry Road from 161 to Warner widen shoulders to accommodate bicycle travel

- Dublin-Granville Road from Hamilton Road (west intersection) to Harlem Road bicycle lanes with road widening
- Morse Road from Hamilton Road to 62 multi-use path
- 2. Transportation improvements to the intersection of New Albany Road and Fodor Road, including but not limited to the construction of a roundabout.
- 3. Acquisition of land and/or construction of facilities that would assist in improving the convenience or efficiency of public transportation in the northeast region. Such improvements would be made in coordination with COTA. The City could, at its option, determine that TIF revenues be used to acquire land or construct facilities that would be owned by either the City or by COTA. The uses of land and/or construction of facilities for these purposes would include, but not be limited to, transit centers, park-and-ride facilities, bus pads, bus shelters or bus turnarounds.
- 4. Acquisition of land and development of appropriate facilities to create and maintain active parks, passive parks, greenways and/or trails.
- 5. Construction of police and/or fire stations.

including, in each case and if applicable, constructing and installing curbs and gutters, medians, public utilities which include water mains, sanitary sewer, and storm sewer, stormwater improvements, burial of utility lines, gas, electric and communications service facilities (including fiber optics), street lighting and signs, sidewalks, bikeways, and landscaping (including scenic fencing and irrigation), traffic signs and signalization, and including design and other related costs, any right-of-way or real estate acquisition, erosion and sediment control measures, grading, drainage and other related work, survey work, soil engineering inspection fees and construction staking, and all other costs and improvements necessary and appurtenant thereto.

Additional Supplements to Supplemented Exhibit C – Public Infrastructure Improvements

In addition to all of the above public infrastructure improvements and projects designated by Ordinances 2117-2005 and 0715-2009, all of the following types of improvements below as well as any projects including but not limited to the below are added as additional supplements to the original and supplemented public infrastructure improvements and projects pursuant to the 2020 City Ordinance this Supplemented Exhibit C-2 is attached hereto.

- 1. Construction, reconstruction, relocation, extension, opening, improving, widening, grading, draining, curbing, changing of the lines and traffic patterns and other improvement of roads, highways, streets, alleys, bridges (roadway/pedestrian), sidewalks, bikeways, medians and viaducts accessible to and serving the public, and providing lighting systems, signalization, and traffic controls, and all other appurtenances thereto.
 - Central Blvd. from the Hamilton Road S-Curve to realigned Dublin-Granville Road
 - Old Dublin-Granville Road from Central Blvd. to Hamilton Road
 - State Route 161 on and off ramp improvements
 - New Albany Road Oblongabout north of Central College Road

- 2. Construction, reconstruction, installation or relocation of public utility improvements (including any underground municipally owned utilities), storm and sanitary sewers (including necessary site grading therefore), water and fire protection systems, and all appurtenances thereto.
- 3. Construction, reconstruction, improving, and equipping of surface or structured public parking facilities.
- 4. Construction, reconstruction, installation or relocation of gas, electric and communication service facilities and all appurtenances thereto.
- 5. Construction or reconstruction of one or more public parks and trails, including grading, trees and other park plantings, park accessories and related improvements, together with all appurtenances thereto.
- 6. Construction/installation of streetscape and landscape improvements including trees and other plantings, tree grates, signage, curbs, gutters, irrigation, sidewalks, street and sidewalk lighting, trash receptacles, benches, newspaper racks, bike racks, relocation burial of overhead utility lines and related improvements, together with all appurtenances thereto.
- 7. Storm water and flood remediation, together with all necessary appurtenances.
- 8. Demolition and excavation, including demolition and excavation on private property when determined to be necessary for economic development purposes, and land acquisition in aid of industry, commerce, distribution, or research.
- 9. Environmental remediation in connection with the development of the TIF parcels.
- 10. Acquisition of real estate or interests in real estate (including easements) necessary to accomplish the foregoing improvements, together with all necessary appurtenances.
- 11. Public art as part of the foregoing improvements, together with all necessary appurtenances.
