Thence South 23° 17′ 46″ East, crossing said 1.273 acre tract, a distance of 25.00 feet to a point on the southerly right of way of said 1.273 acre tract as conveyed to Harrison Road Properties, LLC., an Ohio Limited Liability Company, to a point 25.00 right of centerline station 10+47.71, being the TRUE POINT OF BEGINNING, of the herein tract of land.

The stations and offsets of the above described 0.010 are measured from the centerline of r/w for Harrison Road.
