Being a parcel of land lying on the left side of the existing centerline of right-of-way of Hudson Street (60' R/W – Public) and being more particularly described as follows:

COMMENCING FOR REFERENCE at a 1" iron pin set in a monument box at the intersection of the centerline of right-of-way of Hudson Street and the centerline of right-of-way of Atwood Terrace and being an angle point in the said centerline of right-of-way of Hudson Street, being the southeast corner of Almada as recorded in Plat Book volume 8, page 4-B, and being the southwest corner of Lot 3 of the Partition of Jacob Kiner's Heirs as recorded in Deed Book volume 238, page 554, said pin being at station 41+57.84 of the said centerline of right-of-way of Hudson Street;

northwest corner, the northwest corner of the said Lot 15, and being at the intersection of the existing southerly right-of-way line of Hudson Street and the easterly right-of-way line of Howey Road, said point being 30.00 feet right of the centerline of right-of-way of Hudson Street station 44+48.11, said spike being the **TRUE POINT OF BEGINNING** of the parcel herein described:

Thence along the Grantor's northerly line, the northerly line of the said Lot 15, and along the said existing southerly right-of-way line of Hudson Street, **South 86 degrees 17 minutes 34 seconds East for a distance of 16.87** feet to a point being 30.00 feet right of the centerline of right-of-way of Hudson Street station 44+64.97;

Thence crossing through the lands of the Grantor and through the said Lot 15, South 78 degrees 41 minutes 36 seconds West for a distance of 17.43 feet to a point on the Grantor's westerly line, the westerly line of the said Lot 15, and on the said easterly right-of-way line of Howey Road, said point being 34.52 feet right of the centerline of right-of-way of Hudson Street station 44+48.14;
