Situate in the State of Ohio, County of Franklin, City of Columbus, being in Virginia Military Survey Number 2668, being part of Lot 310 of the Thorpe Brothers Bronx Subdivision of record in Plat Book 12, Page 31, as conveyed to the Ohio Valley District of the Christian and Missionary Alliance in Instrument Number 200906050081709 and Instrument Number 201207310109366, all references to Recorder's Office, Franklin County, Ohio and being more particularly bounded as follows:

Being a parcel of land lying on the left side of the centerline of right-of-way and construction of Sullivant Avenue made by E.P. Ferris & Associates, Inc., and being located within the following described points in the boundary thereof.:

**COMMENCING** at a 3/8" by 8" mag spike with a 1" diameter head, with a 1.5" diameter brass washer stamped "EP FERRIS SURVEYOR 8342" set, being in the centerline of Sullivant Avenue (60'), being said Sullivant Avenue centerline Station 186+27.41;

Thence along said centerline, South 76 degrees 37 minutes 57 seconds West, 7,429.68 feet to a point, being said Sullivant Avenue centerline Station 111+97.73;

Thence across said Sullivant Avenue right-of-way, North 13 degrees 22 minutes 03 seconds West, 30.00 feet to a point, being on the southeasterly corner of said Lot 310, also being on the intersection of the northwesterly right-of-way line of said Sullivant Avenue, and the westerly right-of-way line of South Richardson Avenue (55'), said point being 30.00 feet left of said Sullivant Avenue centerline Station 111+97.73 and being 30.00 feet left of said South Richardson Avenue centerline Station 36+19.96, and being the **TRUE POINT OF BEGINNING** of the parcel herein intended to be described;

Thence along the southeasterly line of said Lot 310 and the northwesterly right-of-way line of said Sullivant Avenue, South 76 degrees 37 minutes 57 seconds West, 6.44 feet to a point,

said point being 30.00 feet left of said Sullivant Avenue centerline Station 111+91.30 and being 36.33 feet left of said South Richardson Avenue centerline Station 36+18.78;

Thence across said Lot 310, North 13 degrees 22 minutes 03 seconds West, 4.55 feet to a point, said point being 34.55 feet left of said Sullivant Avenue centerline Station 111+91.30 and being 37.16 feet left of said South Richardson Avenue centerline Station 36+23.26;

Thence continuing across said Lot 310, North 76 degrees 22 minutes 39 seconds East, 6.10 feet to a point, said point being 34.58 feet left of said Sullivant Avenue centerline Station 111+97.40 and being 31.17 feet left of said South Richardson Avenue centerline Station 36+24.40;

Thence continuing across said Lot 310, North 02 degrees 50 minutes 15 seconds West, 14.16 feet to a point, said point being 48.51 feet left of said Sullivant Avenue centerline Station 111+99.99 and being 31.16 feet left of said South Richardson Avenue centerline Station 36+38.57;

Thence continuing across said Lot 310, North 87 degrees 09 minutes 26 seconds East, 1.16 feet to a point, being on the easterly line of said Lot 310 and the westerly right-of-way line of said South Richardson Avenue, said point being 48.29 feet left of said Sullivant Avenue centerline Station 112+01.13 and being 30.00 feet left of said South Richardson Avenue centerline Station 36+38.57;

Thence along the easterly line of said Lot 310 and the westerly right-of-way line of said South Richardson Avenue, South 02 degrees 50 minutes 34 seconds East, 18.61 feet to the **POINT OF TRUE BEGINNING;**

Subject to all legal rights-of-way, easements, and restrictions, if any, of previous record.

The above described parcel contains 0.001 acres, of which 0.001 acres are contained within Franklin County Auditor's Parcel 010-032952, of which 0.000 acres are in the present road occupied, resulting in a net take of 0.001 acres from Parcel Number 010-032952.

The bearings in this description are based on the Ohio State Plane Coordinate System, South Zone, (NAD 83, 2011 Adjustment). Said bearings originated from a field traverse which was referenced to said coordinate system by GPS observations of selected stations in the Ohio Departments of Transportation Virtual Reference Station network. The portion of the centerline of right-of-way of Sullivant Avenue having a bearing of North 76 degrees 37 minutes 57 seconds East, designated "basis of bearing".
