[Surveyor's description of the premises follows]

Situate in the State of Ohio, County of Franklin, City of Columbus, being in Virginia Military Survey Number 2668, being part of Lot 7 and Lot 8 of Edgewood Place as recorded in Plat Book 10, Page 194, as conveyed to 2352 Sullivan, LLC in Instrument Number 201608190110181, all references to Recorder's Office, Franklin County, Ohio and being more particularly bounded as follows:

Being a parcel of land lying on the right side of the centerline of right-of-way and construction of Sullivan Avenue made by E.P. Ferris & Associates, Inc., and being located within the following described points in the boundary thereof.:

COMMENCING at a 3/8" by 8" mag spike with a 1" diameter head, with a 1.5" diameter brass washer stamped "EP FERRIS SURVEYOR 8342" set, being in the centerline of Sullivan Avenue (60'), being said Sullivan Avenue centerline Station 186+27.41;

Thence along said centerline, South 76 degrees 37 minutes 57 seconds West, 5,813.40 feet to a point, being said Sullivan Avenue centerline Station 128+14.01;

Thence across said Sullivan Avenue right-of-way, South 13 degrees 22 minutes 03 seconds East, 30.00 feet to a point, being on the northwesterly line of said Lot 8 and the southeasterly right-of-way line of said Sullivan Avenue, said point being 30.00 feet right of said Sullivan Avenue centerline Station 128+14.01, and being the **TRUE POINT OF BEGINNING** of the parcel herein intended to be described;

Thence along northwesterly line of said Lot 7 and said Lot 8 and along the southeasterly right-of-way line of said Sullivan Avenue, North 76 degrees 37 minutes 57 seconds East, 52.25 feet to a point, said point being 30.00 feet right of said Sullivan Avenue centerline Station 128+66.26;

Thence across said Lot 7, South 13 degrees 22 minutes 03 seconds East, 5.00 feet to a point, said point being 35.00 feet right of said Sullivant Avenue centerline Station 128+66.26;

Thence continuing across said Lot 7 and across said Lot 8, South 76 degrees 37 minutes 57 seconds West, 52.25 feet to a point, said point being 35.00 feet right of said Sullivant Avenue centerline Station 128+14.01;

Thence continuing across said Lot 8, North 13 degrees 22 minutes 03 seconds West, 5.00 feet to the **POINT OF TRUE BEGINNING**;

Subject to all legal rights-of-way, easements, and restrictions, if any, of previous record.

The above described parcel contains 0.006 acres, of which 0.006 acres are contained within Franklin County Auditor's Parcel 010-019648, of which 0.000 acres are in the present road occupied, resulting in a net take of 0.006 acres from Parcel Number 010-019648.

The bearings in this description are based on the Ohio State Plane Coordinate System, South Zone, (NAD 83, 2011 Adjustment). Said bearings originated from a field traverse which was referenced to said coordinate system by GPS observations of selected stations in the Ohio Departments of Transportation Virtual Reference Station network. The portion of the centerline of right-of-way of Sullivant Avenue having a bearing of North 76 degrees 37 minutes 57 seconds East, designated "basis of bearing".

All monuments found are in good condition unless otherwise noted.

The stationing referenced herein is based on an arbitrary station where the centerline of Sullivant Avenue intersects with the centerline of South Ogden Avenue, being Station 104+84.61.

This description was prepared by Matthew Lee Sloat, Ohio Registered Professional Surveyor 8342, and is based on field surveys conducted by E.P. Ferris and Associates, Inc. in January 2021 under the direct supervision of Matthew Lee Sloat, Ohio Registered Professional Surveyor 8342.
