KEY AGREEMENT TERMS:

- Agreement commences on the date of signed document (Estimated April 1, 2021)
 - With the proposed 4/1/21 start date, we would apply a credit of \$1,032/month for the 4 remaining months (total credit = \$4,128) for the Public Service contract, which ends August 1st, 2021.
- Pricing fixed, with no increases, based on a 5-year agreement term
- City of Columbus may terminate with 30 days' notice for any reason
- iReportSource may terminate for non-payment 30 days past-due
- Terms are Net 30 (50% due upon signing, and the remaining balance shall be due by June 30, 2021)

KEY COMMITMENTS and UNDERSTANDINGS:

- Unlimited Licenses for the entire city all departments, all employees
 - You will be able to set people up at whatever authority level is appropriate (reporter, supervisor, collaborator and administrator)
- Unlimited Support and Training
 - Customization work, like what we have done for the Public Service group, is included in the
 onboarding and setup fee, and we understand there will be more along the way. We cannot satisfy
 every custom request of course, but we will sure make every effort to make sure the system does what
 it needs to do for all the city departments.
 - We will provide periodic on-site training as requested.
- 2021 Implementation Schedule
 - We realize this will happen on your schedule as departments come on board, and we will have the necessary resources to be prepared for that.

- Annual License Fee: \$109,000/year
- Onboarding & Setup Fee: \$9,300 (One-time fee for department onboarding)

- Public Service Credit: (\$4,128) applied to initial invoice
