
BACKGROUND:

The site is developed with a single-unit dwelling in the L-R-2, Limited Residential District.
 The requested R-2, Residential District will permit the owner to install an above-ground pool, subject to R-2 district development standards.

- North, south, east, and west of the site are single-unit dwellings in the L-R-2, Limited Residential District.
- The site is within the planning boundaries of the South East Land Use Plan (2018), which recommends "Low Density Residential (4-6 du/ac)" land uses at this location.
 Additionally, the Plan includes complete adoption of the Columbus Citywide Planning Policies (C2P2) Design Guidelines (2018).
- The site is located within the boundaries of the Greater South East Area Commission, whose recommendation is for approval.


CITY DEPARTMENTS' RECOMMENDATION: Approval.




Z21-023 6515 Cloverlawn Cir. Approximately 0.15 acres L-R-2 to R-2
