Work consists of constructing approximately 9200 LF of 12" to 30" storm sewer and appurtenances, 2 bioretention basins, approximately 9400 LF of 6"-8" water main and appurtenances, roadway improvements, and other such work as may be necessary to complete the contract, in accordance with the drawings.

The Community Planning Area is “39 – Clintonville”.

6. A narrative timeline for the contract including a beginning date, beginning and ending dates for known phases of the contract and a projected ending date.

All work except the Period of Establishment Season 1 and Season 2 shall be substantially completed in a manner acceptable to the City within **12 months** after the date of the Notice to Proceed.

7. A narrative discussing the economic impact or economic advantages of the project; community outreach or input in the development of the project; and any environmental factors or advantages of the project.

This project will install storm infrastructure to mitigate street and yard flooding that occurs in the Old Beechwold Historic Neighborhood located within Clintonville planning area. Two regional biobasins will be constructed to capture and treat non-point source stormwater runoff to improve water quality within the receiving streams. It will also replace existing 6-inch and 8-inch water lines that have a high break frequency. Replacement of these water lines will improve water service, decrease burden on water maintenance operations, and reduce water loss. Streets within the project area will be repaved as part of the project. Several meetings were held with the Old Beechwold Association to solicit input during project design.

8. An estimate of the full cost of the Contract including a separate estimate of any and all phases or proposed future contract modifications.

The bid amount and proposed award amount is \$ \$6,948,336.60, including a 20% construction contingency amount that will be utilized to fund needed and approved changes in the work. No contract modifications are anticipated at this time; however, construction exigency might later compel modification of this contract, if unforeseen difficulties are encountered.
