Notes and Assumptions

- (1) Professional Services pricing is an estimate and is based on assumptions that have not been confirmed. In order to create a formal Scope of Work and a more accurate professional services bid, a detailed discussion of actual project requirements will be necessary.
- (2) FCS services include: remote kickoff, single system install/configuration and Itron Mobile setup and testing for one environment (Prod), Training (FCS Operator 'Life of a Route' Desktop, handheld, and Itron Mobile training, Consulting/support during test phase, Go-Live Production Cutover support. Monday through Friday, 8AM to 5PM standard business hours.
- (3) The software fees are based on 1 production environment. Pricing for on-premise software also includes 1 test environment. If additional environments are required additional fees would apply.
- (4) FCS software is provided with one copy of Crystal Reports Developer. Additional copies can be purchased separately at \$595.00 each.
- (5) Pricing shown here does not include third party products needed for this system such as servers, PCs, operating systems, and Oracle or SQL Server database server.
- (6) The Software Maintenance start date commences on the first of the month following Software delivery.
- (7) The software fees are based on 1 production environment. Pricing for on-premise software also includes 1 test environment. If additional environments are required additional fees would apply.
- (8) Itron Mobile is offered as an annual subscription with a minimum one-year term. FCS v4.0 must be fully tested and operational prior to Itron Mobile Application services.
- (9) Itron Mobile requires the FCS server to be connected to the Itron Cloud and the FCS server to be maintained with the latest FCS software compatible with the Itron Cloud and Itron Mobile app.
- (10) Access to certain features of Itron mobile is dependent upon subscription type.
- (11) Pricing is based on existing agreements or Itron's standard terms and conditions.
- (12) Freight and taxes are not included. Prices are in US dollars. Prices are valid for 180 days.
