Sir,

The following investigation was conducted concerning the City of Columbus' 2021 annual objection to the renewal of liquor permit **7641785** issued to **S Livingston Inc.**, which is doing business as **Livingston Shell** located at **1937 E. Livingston Avenue, Columbus, Ohio 43209**. The recorded owners of said permit are **Faisal Ilyas and Suman Zia**.

After reviewing the State of Ohio, Franklin County, and City of Columbus records regarding the above liquor permit establishment, the following information has been compiled to support the objection to the renewal of the aforementioned permit issued by the State of Ohio.

The above listed liquor establishment has been issued a **C1 and C2** permits by the Division of Liquor. This permit grants the permit holder the privilege to sell alcoholic beverages at the above listed address.

A review of the Columbus Division of Police records revealed the Division of Police has created **(71) seventy-one** official police reports concerning incidents at the listed liquor establishment between **January 2020** and **November 2021**. These reports referenced homicide, felony assaults, shootings, stabbings, robberies, menacing with threats of violence, intoxicated individuals needing assistance, assaults, motor vehicle thefts, possession of illegal narcotics, overdoses, and arrest of persons with felony warrants, including:



In addition, the Columbus Division of Police have been dispatched to **1937 E. Livingston Avenue, Columbus, Ohio 43209** on **(372) three hundred seventy-two** calls for service, **(227) two hundred and twenty-seven** in 2020, and **(145) one hundred forty-five** in 2021 at **Livingston Shell**. These calls for service include responses to shootings, persons with a gun or knife, cuttings/stabbings, robberies, shots fired, fights, assaults, narcotics complaints, overdoses, intoxicated individuals needing assistance, disturbances (including disturbances with a high risk of violence and disturbances involving intoxicated individuals and open containers), trespassing, domestic violence, O.V.I.'s, motor vehicle thefts, and property destruction.

The Columbus Division of Fire was also dispatched to the location **(35) thirty-five** times from October 2020 through October 2021, including for **(9) nine** overdoses.
