The following investigation was conducted concerning the City of Columbus' 2021 annual objection to the renewal of liquor permit **24129960010** issued to **Easy Stop I Inc.**, which is doing business as **Convenient Plus Food Mart** located at **3351 East Main Street, Columbus, Ohio 43213**. The recorded owner of said permit is **Muhammad Ashraf**.

The City of Columbus also objected to the renewal of this permit in November 2020. The Ohio Department of Commerce Division of Liquor Control has not yet held a final hearing on that objection.

After reviewing the State of Ohio, Franklin County, and City of Columbus records regarding the above liquor permit establishment, the following information has been compiled to support the objection to the renewal of the aforementioned permit issued by the State of Ohio.

The above listed liquor establishment has been issued a **C1** permit by the Division of Liquor. This permit grants the permit holder the privilege to sell alcoholic beverages at the above listed address.

A review of the Columbus Division of Police records revealed the Division of Police has created (28) twenty-eight official police reports concerning incidents at the listed liquor establishment between January 2020 and November 2021. These reports referenced shootings, firearms recovered, shots fired, weapons offenses, felony assaults, possession and sale of illegal drugs and narcotics, assaults, felony theft, robberies, domestic violence, and motor vehicle thefts, including:
