The Transportation Division is responsible for maintaining the City's roadway system through a viable renovation program. A concrete rehabilitation project is needed to prevent premature deterioration of the City's concrete roadways and to perform emergency repairs. This contract has been prepared with two parts: Part 1 consists of pre-selected streets requiring concrete rehabilitation; and, Part 2 consists of an "on-call" service for emergency and non-emergency concrete repairs. The locations and estimated quantities

associated with Part 2 will be provided to the contractor at a later time in the form of "work orders".

This legislation authorizes the City to enter into a contract in an amount up to \$225,993.50 for the Concrete Rehabilitation - 2008 project and to pay construction inspection costs up to \$22,599.50. This project consists of concrete street repair within the City of Columbus and such other work, as necessary, to complete the contract in accordance with the plans and specifications. The estimated Notice to Proceed date is May 2008 with a contract duration of 365 days. This project was let by the Transportation Division and advertised in the City Bulletin, Dodge Reports and the Builders Exchange. Fourteen bidders/suppliers were solicited (13 majority, 1 minority) and four (4) bids were received (4 majority, 0 minority) on March 27, 2008 and tabulated on March 28, 2008 as follows:

Award is to be made to G. Marchi & Son, cc #31-1632119 (expires April 1, 2010) as the lowest, best, most responsive and most responsible bidder for \$225,993.50.

Fiscal Impact: This project is budgeted within the 2007 Capital Improvement Budget. The \$248,593.00 authorized for this project is funded from the Voted 1995, 1999, 2004 Streets and Highways Fund.

Emergency action is requested to allow this project to proceed and be completed this construction season.

To authorize the Public Service Director to enter into a contract with G. Marchi & Son, LLC for the Concrete Rehabilitation - 2008 project for the Transportation Division; to authorize the expenditure of \$248,593.00 from the Voted 1995, 1999, 2004 Streets and Highways Fund; and to declare an emergency. (\$248,593.00)

WHEREAS, the Transportation Division is responsible for maintaining the City's concrete roadways; and

WHEREAS, concrete rehabilitation is needed to prevent early deterioration of the City's concrete roadways; and

WHEREAS, formal competitive bids were received on March 27, 2008, and tabulated on March 28, 2008 by the Transportation Division for the Concrete Rehabilitation - 2008 project and a satisfactory low bid was received; and

WHEREAS, funds are budgeted and available for this expenditure; and

WHEREAS, an emergency exists in the usual daily operation of the Public Service Department, Transportation Division, in that this contract should be awarded so that the work may proceed without delay and be completed this construction season, thereby preserving the public health, peace, property, safety and welfare; now, therefore

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBUS:

SECTION 1. That the Public Service Director be and hereby is authorized to enter into a contract with G. Marchi & Son, LLC, 1009 East 5th Avenue, Columbus, Ohio 43201 for the Concrete Rehabilitation - 2008 project in an amount not to exceed \$225,993.50 in accordance with the applicable specifications and plans on file in the office of the Transportation Administrator, which are hereby approved, and to provide for construction inspection services in the amount of \$22,599.50.

SECTION 2. That for the purpose of paying the cost of the contract and inspection, the sum of \$248,593.00 or so much thereof as may be needed be and hereby is authorized to be expended from Fund 704, the Voted 1995, 1999, 2004 Streets and Highways Fund, Department No. 59-09, Transportation Division, O.L. 01/03 Codes 06/6631, OCA Code 644385 and Project 530103 (Arterial Street Rehabilitation).

SECTION 3. That the City Auditor is authorized to make any accounting changes to revise the funding source for all contracts or contract modifications associated with this ordinance.

SECTION 4. That for the reasons stated in the preamble hereto, which is hereby made a part hereof, this ordinance is hereby declared to be an emergency measure and shall take effect and be in force from and after its passage and approval by the Mayor or ten days after passage if the Mayor neither approves nor vetoes the same.
