**WHEREAS**, Pete picked up the mantle from Hap Cremean and worked tirelessly to ensure the City's annexation policy remain tied to water and sewer contracts, sharing his knowledge and infinite wisdom with many who now know more about the city's annexation policy than ever thought possible; and
