WHEREAS, for more than thirty years serving as a proud leader in Columbus' labor movement, Mark Flurharty has led countless contract negotiations, empowering Columbus-area workers to have their voices heard and interests represented through the power of collective bargaining; and

WHEREAS, Fluharty's staunch advocacy played a crucial role in ushering in a new era of worker protections for workers in the City of Columbus of Central Ohio region, including Columbus' wage theft law, freelance worker protections, and the utilizations of community benefit agreements for public construction projects; and

WHEREAS, Mark served on the Board of Trustees for the United Way of Central Ohio, the Board for Creating Central Ohio Futures, and the City's Civilian Police Review Board, demonstrating his dedication to public service and the community; and

WHEREAS, for more than a decade, Mark has helped coordinate food donations in a partnership with St. Stephens Community House for the Christmas Cares, Union Shares annual event that feeds over 3,000 families each holiday season; and
