To authorize the City Auditor to transfer \$198,000.00 within the voted Recreation and Parks Bond fund; to amend the 2012 Capital Improvements Budget Ord. 0368-2012; to authorize and direct the Director of Recreation and Parks to enter into contract with Steve Kolwicz dba POD Design, LLC for professional services related to Blackburn Park & Indian Mound Park Spraygrounds Design; to authorize the expenditure of \$180,000.00 and a contingency of \$18,000.00 for a total of \$198,000.00 from the Voted Recreation and Parks Bond Fund; and to declare an emergency. **WHEREAS**, funds are being moved to alternate projects within Fund 702 to establish correct funding project detail location for the Blackburn Park & Indian Mound Park Spraygrounds Design; and

**WHEREAS**, the 2012 Capital Improvement Budget will be amended to reflect the fund transfers from projects within Fund 702; and

**WHEREAS**, services related to Blackburn Park & Indian Mound Park Spraygrounds Design; and

**WHEREAS**, an emergency exists in the usual daily operation of the Recreation and Parks Department in that it is immediately necessary to enter into said contract so that work may begin during the current construction season; **NOW, THEREFORE**

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBUS:**

**SECTION 1.** That the Director of Recreation and Parks be and he is hereby authorized and directed to enter into contract with Steve Kolwicz dba POD Design, LLC for professional services related to Blackburn Park & Indian Mound Park Spraygrounds Design.

**SECTION 2.** That the City Auditor is hereby authorized to transfer \$198,000.00 within the voted Recreation and Parks Bond Fund No. 702 for the projects listed below:
