Title: To authorize Columbus City Council to appropriate and expend \$8,000.00 from the Jobs Growth

Fund, to enter into a contract with Sinclair Media II for sponsorship of WSYX ABC 6's February 18, April 29, August 5 and October 14, 2015 Job Boot Camps, and to declare an emergency. (\$8,000.00)

Passage of this ordinance will enable Columbus City Council to expend \$8,000.00 from the Jobs Growth Fund, and to enter into a contract with Sinclair Media II for sponsorship of four WSYX ABC 6's Job Boot Camps.

The ABC 6 Job Boot Camp is free to all residents, and will take place on February 18, April 29, and August 5, 2015 at the Aladdin Shrine Center from 11:00 a.m. to 3:00 p.m. The October 14, 2015 event will take place from 11:00 a.m. to 3:00 p.m. at a location yet to be determined. Representatives from approximately 20 companies will be at each event interviewing attendees on the spot, and providing guidance on effective resume writing, interviewing, and networking.

Sponsorship of this event aligns with Columbus City Council's priority of promoting opportunities for job creation, workforce development and technology integration.

FISCAL IMPACT: Funding for such sponsorship was allotted in the Jobs Growth Fund, Fund 015.

EMERGENCY DESIGNATION: It is requested that this Ordinance be handled in an emergency manner due to the time sensitive deadlines of event sponsorship.

To authorize Columbus City Council to appropriate and expend \$8,000.00 from the Jobs Growth Fund, to enter into a contract with Sinclair Media II for sponsorship of WSYX ABC 6's February 18, April 29, August 5 and October 14, 2015 Job Boot Camps, and to declare an emergency. (\$8,000.00)

WHEREAS, In 2009, WSYX ABC 6 hosted its first Job Boot Camp; and

WHEREAS, Since that time, well over 25,000 people have attended an ABC 6 Job Boot Camp; and

WHEREAS, it is a top priority of Columbus City Council to support efforts that enhance regional job creation,

workforce development and technology integration; and

WHEREAS, on February 18, April 29, August 5 and October 14, 2015, Columbus City Council will again participate at the Job Boot Camp by coordinating and staffing a computer resource bank whereby visitors to the event may submit job applications online; and

WHEREAS, passage of the this legislation authorizes Columbus City Council to appropriate and expend \$8,000.00 from the Jobs Growth Fund, and to enter into a contract to sponsor four 2015 WSYX ABC 6 Job Boot Camps; and

WHEREAS, an emergency exists in the usual daily operation of the City of Columbus in that it is immediately necessary to appropriate said funds to have funding available for necessary expenditures; now, therefore:

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBUS:

SECTION 1. That the City Auditor be and he is hereby authorized and directed to appropriate \$8,000.00 in the Jobs Growth Fund as follows:

SECTION 2. That Columbus City Council is hereby authorized to enter into contract with Sinclair Media II, Inc./dba WSYX ABC 6 to support and sponsor the February 18, April 29, August 5 and October 14, 2015 Job Boot Camp.

SECTION 3. That the expenditure of \$8,000.00 be and hereby is authorized in:

SECTION 4. That \$8,000 will be expended to Sinclair Media II in four equal installments of \$2,000 following the culmination of each 2015 job boot camp event.

SECTION 5. That for the reasons stated in the preamble hereto, which is hereby made a part hereof, this ordinance is hereby declared to be an emergency measure and shall take effect and be in force from and after its passage and approval by the Mayor, or 10 days after passage if the Mayor neither approves nor vetoes the same.
