BACKGROUND: The Purchasing Office has established a Universal Term Contract for Process Control Computer Maintenance with Telvent USA LLC. The Division of Power and Water would like to establish a Blanket Purchase Order, based on the current contract for Process Control Computer Maintenance. The Process Control Computer Maintenance is an automated computer system that monitors and controls the water production in the treatment plants and in the distribution system, monitors and controls flow of water throughout the City.

FISCAL IMPACT: The Division of Power and Water has allocated \$78,788.00 for this commodity in the 2012 budget. \$212,211.35 was expended for Maint. Serv. - Computer Programs in FY2010. \$318,547.62 was expended for Maint. Serv. - Computer Programs in FY2011.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBUS:

Section 1. That the Director of Finance and Management be and is hereby authorized to establish Blanket Purchase Order, for Process Control Computer Maintenance, with Telvent USA LLC, for the Division of Power and Water, Department of Public Utilities.
