WHEREAS, bids were received by the Recreation and Parks Department on November 23, 2010 for the Westgate Well Drilling Project; and

WHEREAS, it is necessary to enter into contract with Beinhower Bros. Drilling Co. for the Westgate Well Drilling Project for the well installation and other such work as may be necessary; NOW, THEREFORE

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBUS:

SECTION 1. That the Director of Recreation and Parks be and he is hereby authorized and directed to enter into contract with Beinhower Bros. Drilling Co. for the Westgate Well Drilling Project for the well installation and other such work as may be necessary.

SECTION 2. That the expenditure of \$38,500.00, or so much thereof as may be necessary, be and is hereby authorized from the Voted Recreation and Parks Bond Fund, to pay the cost thereof, as follows:

Fund #702, Project #510017-100004 Neighborhood Park Renovations, OCA#721704, Obj Level 3# 6621

SECTION 3. That the City Auditor is authorized to make any accounting changes to revise the funding source for all contracts or contract modifications associated with this legislation.

SECTION 4. That the ordinance shall take effect and be in force from and after the earliest period allowed by law.
