## **Legislation Text**

Columbus Public Health has been awarded additional funding from the U.S. Department of Health and Human Services. This ordinance is needed to accept the additional funding of \$900,000.00 in grant monies for the Healthy Start grant program for the period of November 1, 2014 through October 31, 2015.

The Healthy Start grant program enables Columbus Public Health to conduct care coordination in the project area neighborhoods of South Linden, the Near South, and the Near East, focusing primarily on perinatal and infant clients and their families. The goal of the program is to improve perinatal delivery systems in the project communities.

This ordinance is submitted as an emergency so as to allow the financial transactions to be posted in the city's accounting system as soon as possible, given the additional funding start date of November 1, 2014. Up to date financial posting promotes accurate accounting and financial management.

**FISCAL IMPACT:** The Healthy Start grant program is entirely funded by the U.S. Department of Health and Human Services and does not generate revenue or require a city match.

To authorize and direct the Board of Health to accept additional funding from the U.S. Department of Health and Human Services in the amount of \$900,000.00 for the Healthy Start Grant Program; to authorize the appropriation of \$900,000.00 to the Health Department in the Health Department Grants Fund; and to declare an emergency. (\$900,000.00)

WHEREAS, additional grant funding has been made available from the U.S. Department of Health and Human Services; and,

WHEREAS, it is necessary to authorize the Board the Health to accept \$900,000.00 in additional grant funds that have been made available through the U.S. Department of Health and Human Services for the Healthy Start grant program for the period of November 1, 2014 through October 31, 2015, and to appropriate these monies to the Health Department; and,

WHEREAS, this ordinance is submitted as an emergency so as to allow the financial transaction to be posted in the city's accounting system as soon as possible. Up to date financial posting promotes accurate accounting and financial management; and,

WHEREAS, an emergency exists in the usual daily operation of Columbus Public Health in that it is immediately necessary to accept these additional grant funds from the U.S. Department of Health and Human Services and to appropriate these funds to the Health Department for the immediate preservation of the public health, peace, property, safety, and welfare; Now, therefore:

## BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBUS:

**SECTION 1.** That the Board of Health is hereby authorized and directed to accept additional funding of \$900,000.00

from the U.S. Department of Health and Human Services for the Healthy Start grant program for the period of November 1, 2014, through October 31, 2015.

**SECTION 2.** That from the unappropriated monies in the Health Department Grant Fund, Fund No. 251, and from all monies estimated to come into said fund from any and all sources during the twelve months ending October 31, 2015, the sum of \$900,000.00, plus any eligible interest earned during the grant period, is hereby appropriated to the Health Department, Division No. 50-01, as follows:

OCA: 501440; Grant No.: 501440; OL1:01; Amount: \$400,000.00 OCA: 501440; Grant No.: 501440; OL1:02; Amount: \$80,000.00 OCA: 501440; Grant No.: 501440; OL1:03; Amount: \$420,000.00

Total for Grant No. 501440: \$900,000.00

**SECTION 3.** That the monies appropriated in the foregoing Section 2 shall be paid upon the order of the Health Commissioner, and that no order shall be drawn or money paid except by voucher, the form of which shall be approved by the City Auditor.

**SECTION 4.** That at the end of the grant period, any repayment of unencumbered balances required by the grantor is hereby authorized and any unused city match monies may be transferred back to the city fund from which they originated in accordance with all applicable grant agreements, and the City Auditor shall establish such accounting codes as necessary.

**SECTION 5.** That the funds necessary to carry out the purpose of this ordinance are hereby deemed appropriated, and the City Auditor shall establish such accounting codes as necessary.

**SECTION 6.** That for reasons stated in the preamble hereto, which is hereby made a part hereof, this ordinance is hereby declared to be an emergency measure and shall take effect and be in force from and after its passage and approval by the Mayor, or ten days after passage if the Mayor neither approves nor vetoes the same
