Title: To authorize the Director of Public Utilities to modify the construction administration and inspection services agreement with DLZ Ohio, Inc. in the amount of \$1,091,620.73, to authorize the appropriation and transfer of \$157,193.35 from the Sewer System Reserve Fund to the Ohio Water Pollution Control Loan Fund; the appropriation of \$397,956.21 in loan proceeds from the Ohio Water Pollution Control Loan Fund; the transfer of \$49,238.44 from within the 1991 Voted Sanitary Bond Fund; to authorize the expenditure of \$1,042,382.29 from the Ohio Water Pollution Control Loan Fund; and the expenditure of \$49,238.44 from the 1991 Voted Sanitary Bond Fund; for the Division of Sewerage and Drainage; and to declare an emergency.
