# BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBUS:

**SECTION 1.** That the Director of Recreation and Parks be and he is hereby authorized and directed to enter into contract with Advanced Engineering Consultants in accordance with the plans and specifications on file in the Recreation and Parks Office.

**SECTION 2.** That the expenditure of \$110,000.00 or so much thereof as may be necessary, be and is hereby authorized, to pay the cost thereof, as follows:

#### Fund 746, Recreation and Parks Build America Bonds Project # 510716-100001 Security Enhancements, OCA#767601, Obj Level 3 #6620

**SECTION 3.** That the City Auditor is authorized to make any accounting changes to revise the funding source for all contracts or contract modifications associated with this legislation.

**SECTION 4**. That for the reasons stated in the preamble hereto, which is hereby made a part hereof, this ordinance is hereby declared to be an emergency measure and shall take effect and be in force from and after its passage and approval by the Mayor, or 10 days after passage if the Mayor neither approves nor vetoes the same.
