Title: To authorize the Public Service Director to increase an existing Guaranteed Maximum Cost Agreement with the Urban Loft Ventures I LLC for the construction of downtown streetscape improvements at the northeast corner of Third Street and Gay Street for the Transportation Division; to waive the competitive bidding requirements of the Columbus City Code, 1959; to amend the 2007 C.I.B.; to authorize the transfer of \$4,229.00 within the 1995, 1999, 2004 Voted Streets and Highways Fund; to authorize the expenditure of an additional \$129,229.00 to be added to the \$200,000.00 already authorized in Ordinance 1559-2006 for a total project cost of \$329,229.00 from the Voted 1995, 1999, 2004 Streets and Highways Fund and to declare an emergency.
