BACKGROUND: This ordinance authorizes the Finance and Management Director to enter into a contract on behalf of the Office of Construction Management with PK Builders, LLC. for the renovation of the roof at Police Substation No. 7, 1475 Granville Street. This renovation is necessary as the current roof has exceeded its life expectancy. Replacing the roof now will avoid potentially expensive repairs to the structure of the building in the future.

Formal bids were solicited and six companies submitted a bid on August 17, 2010 as follows (0 FBE, 1 ^MBE):

PK Builders, LLC. \$47,800.00

Wingler Construction \$49,400.00
^Smith Roofing \$59,000.00
General Maintenance & Engineering Co. \$64,393.00

M. Smith Roofing \$74,987.00

Harold J. Becker Company Inc. \$90,925.00

The Office of Construction Management recommends the bid award be made to the most responsive and responsible bidder, PK Builders, LLC.

Emergency action is requested so that the roof renovation can occur immediately, thereby preventing structural damage as well as ensuring work is completed during good weather.

PK Builders, Inc. Contract Compliance No. 31-1630301, expiration date June 19, 2011.

Fiscal Impact: This ordinance authorizes the expenditure of \$47,800.00 from the Safety Voted Bond Fund.

To authorize the Finance and Management Director to enter into a contract on behalf of the Office of Construction Management with PK Builders, LLC. for the renovation of the roof at Police Substation No. 7, to authorize the expenditure of \$47,800.00 from the Safety Voted Bond Fund; and to declare an emergency. (\$47,800.00)

WHEREAS, it is necessary to renovate the roof for the Division of Police, Substation No. 7, 1675 Granville Street; and

WHEREAS, PK Builders, LLC. is the most responsive, responsible, and best bidder; and

WHEREAS, an emergency exists in the usual daily operations of the Finance and Management Department, Office of Construction Management, in that it is immediately necessary to authorize the Director of Finance and Management to enter into a contract with PK Builders, LLC. for the renovation of the roof for the Division of Police, Substation No. 7, 1475 Granville Street, so that the roof renovation can occur immediately, thereby preventing structural damage, thereby preserving the public health, peace, property, safety, and welfare; now, therefore:

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBUS:

SECTION 1. That the Finance and Management Director is hereby authorized to enter into a contract for the Office of Construction Management with PK Builders, LLC. for the renovation of the roof for the Division of Police, Substation No. 7, 1475 Granville Street.

SECTION 2. That the expenditure of \$47,800.00, or so much thereof as may be necessary in regard to the action authorized in SECTION 1, be and is hereby authorized and approved as follows:
