- **1. BACKGROUND:** This legislation authorizes the Director of Public Utilities to enter into a construction contract with Fields Excavating, Inc., in the amount of \$2,162,747.72; to encumber funds with the Transportation Division for inspection, testing, and prevailing wage coordination services in the amount of \$326,500.00; to authorize the City Auditor to transfer a total of \$2,489,247.72 within the Storm Sewer Bond Fund; and to amend the 2007 Capital Improvements Budget; all in connection with the Midland/Eakin Stormwater System Improvements Project.
- **2. CONSTRUCTION CONTRACT AWARD:** The Director of Public Utilities publicly opened 9 bids on October 3, 2007. These bids were received from: Fields Excavating, Inc., \$2,162,747.72; Nickolas Savko & Sons, Inc., \$2,254,251.84; Elite Excavating, \$2,272,256.40; Shelly & Sands, \$2,302,053.60; Trucco Construction, \$2,470,372.20; George J. Igel & Company, Inc., \$2,579,535.90; Tata Excavating, Inc., \$2,621,511.90; Complete General Construction Co., \$2,801,466.00; and Columbus Asphalt Paving, Inc., \$2,914.111.80.

Fields Excavating, Inc. is the lowest, responsible, responsive bidder. Additional information regarding each bidder, description of work, contract timeframe and detailed amounts can be found on the attached Legislation Information Form.

3. FISCAL IMPACT: This legislation includes a transfer of funds within the Storm Sewer Bonds Fund and an amendment to the 2007 Capital Improvements budget to allow sufficient cash and authority in the proper account for this project.

To authorize the Director of Public Utilities to execute a construction contract with Fields Excavating, Inc.; to provide for payment of inspection, material testing and related services to the Transportation Division for the Midland/Eakin Stormwater System Improvements; for the Division of Sewerage and Drainage; to authorize the transfer and expenditure of \$2,489,247.72 within the Storm Sewer Bond Fund; and to authorize an amendment to the 2007 Capital Improvements Budget;. (\$2,489,247.72)

WHEREAS, nine bid proposals were received and publicly opened in the offices of the Director of Public Utilities on October 3, 2007 for the construction of the Midland/Eakin Stormwater System Improvements; and

WHEREAS, it is necessary to authorize the Director of the Department of Public Utilities to award and execute a construction contract and to encumber and expend funds to provide for payment of inspection, testing and prevailing wage coordination services costs associated with the Midland/Eakin Stormwater System Improvements project; and

WHEREAS, it is necessary for this Council to authorize the City Auditor to transfer funds within the Storm Sewer Bond Fund; and

WHEREAS, it is necessary to authorize an amendment to the 2007 Capital Improvements Budget for purposes of providing sufficient funding and spending authority for the aforementioned project expenditure; and

WHEREAS, significant flooding and other stormwater problems have been identified through customer complaints for the area covered by this project; now therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBUS:

SECTION 1. That the Director of Public Utilities be, and hereby is, authorized to award and execute a contract for construction of the Midland/Eakin Stormwater System Improvements project with the lowest and best bidder, Fields Excavating, Inc., 177 Township Rd. 191; Kitts Hill, Ohio 45645; in the amount of \$2,162,747.72 in accordance with the terms and conditions of the contract on file in the Office of the Division of Sewerage and Drainage; and to obtain the necessary inspection, testing and prevailing wage coordination services from the Transportation Division; and to pay up to a maximum amount of \$326,500.00.

SECTION 2. That the said construction company shall conduct the work to the satisfaction of the Director of Public Utilities and the Administrator of the Division of Sewerage and Drainage.

SECTION 3. That the City Auditor is hereby authorized and directed to transfer any unencumbered balance in the project account to the unallocated balance within the same fund upon receipt of certification by the Director of the Department administering said project that the project has been completed and the monies no longer required for said project; except that no transfer shall be made from a project account by monies from more than one source.

SECTION 4. That the City Auditor is authorized to establish proper project accounting numbers as appropriate.

SECTION 5. That the City Auditor is authorized to make any accounting changes to revise the funding source for all contracts or contract modifications associated with this ordinance.

SECTION 6. That for the purpose of paying the cost of the construction contract, the cost of inspection, testing and prevailing wage coordination services, the following expenditure, or as much thereof as may be needed is hereby authorized as follows: Division 60-15, Storm Sewer Bond Fund No. 685, Project 610734, Object Level Three 6621, OCA Code 685734, Amount \$2,489,247.72.

SECTION 7. That the City Auditor is hereby authorized to transfer \$2,489,247.72 within the Storm Sewer Bonds Fund, Fund 685, Division of Sewerage and Drainage, Division 60-15, Obj. Level 3 6621 as follows:
