Background:

This ordinance will authorize the Director of Recreation and Parks to enter into a contract with Mid Ohio Electric for Raymond Golf Irrigation Improvements.

One bid was received by the Recreation and Parks Department on November 20, 2007 for the Golf Course Improvements as follows:

File #: 2012-2007, Version: 1

Mid Ohio Electric Status Amount
Majority \$65,914.06

Services will include: Provide labor, material, and equipment complete for the control and monitoring of three individual well pumps at three different locations on the golf course discharging into the same golf course irrigation system and other such work as may be necessary to complete the contract in accordance with the plans and specifications

A contingency amount of \$7,000.00 is being included in this project.

Contract Compliance Number for Mid Ohio Electric is 31-4416140

Emergency action is necessary to allow project to be complete prior to Spring golf season.

Fiscal Impact:

\$72,914.06 is budgeted in the Recreation and Parks Voted 1999/2004 Bond Fund to meet the financial obligation of this project.

Funding contingent upon 2007 Bond sale proceeds.

To authorize the Director of Recreation and Parks to enter into contract with Mid Ohio Electric for Raymond Golf Irrigation Improvements project, to authorize the expenditure of \$72,914.06 from the Recreation and Parks Voted bond fund, and to declare an emergency. (\$72,914.06)

WHEREAS, bids were received by the Recreation and Parks Department on November 20, 2007 and the contract for Raymond Irrigation Improvements will be awarded on the basis of the lowest and best responsive and responsible bidder; and

WHEREAS, an emergency exists in the usual daily operation of the Recreation and Parks Department in that it is immediately necessary to enter into contract to allow work to be complete prior Spring golf season; now, therefore

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBUS:

- **SECTION 1.** That the Director of Recreation and Parks be and he is hereby authorized and directed to enter into contract with Mid Ohio Electric for the Raymond Irrigation Improvements, in accordance with plans and specifications on file in the Recreation and Parks Department.
- **SECTION 2.** That the expenditure of \$72,914.06, or so much thereof as may be necessary, be and is hereby authorized, to pay the cost thereof, as follows:

\$72,914.06 Recreation and Parks Voted Bond Funds: Fund No. 702, Dept. 51-01, Project 510429, OCA Code 644526, and Object Level 3 No. 6621

- **SECTION 3.** That the City Auditor is authorized to make any accounting changes to revise the funding source for all contracts or contract modifications associated with this legislation.
- **SECTION 4.** That for the purpose of paying for any contingencies which may occur during this project, the amount of \$7,000.00 has been included in Section 2, above. This amount will be expended only after approval by the Director of the Recreation and Parks Department, certification by the City Auditor, and approval of the City Attorney.
- **SECTION 5**. That for the reasons stated in the preamble hereto, which is hereby made a part hereof, this ordinance is hereby declared to be an emergency measure and shall take effect and be in force from and after its passage and approval by the Mayor, or ten days after passage if the Mayor neither approves nor vetoes
