BACKGROUND: To change the Company Name and Federal Identification number for contract number FL003007 for the purchase of Auto Body Repair Services for Fleet Management. This ordinance authorizes the assignment of all past, present and future business resulting from FL003007 by the City of Columbus with A-Tech Auto Restylin', FID 311681336 to A-Tec Upholstery & Body Shop, FID 261813154. CC# active through 5/20/10.

1. <u>Amount of additional funds</u>: No additional funds are necessary to modify the option contract.

2. <u>Reason additional needs were not foreseen</u>: The current supplier changed company name and FID number.

3. <u>Reason other procurement processes not used</u>: The same exact product is required as originally bid. No lower pricing/more attractive terms and conditions are anticipated through rebidding at this time.

4. <u>How cost was determined</u>: Terms and conditions are in accordance with the original agreement.

FISCAL IMPACT: No funds are required to modify the option contract. Fleet Management must set aside their own funding for their estimated expenditures.

In order to maintain uninterrupted services to City agencies using this Universal Term Contract, this ordinance is being submitted as an emergency.

WHEREAS, the Finance & Management Department/Purchasing Office established the contract with A-Tech Auto Restylin' for the option to purchase Auto Body Repair Services; and

WHEREAS, A-Tech Auto Restylin' changed their name and FID number, in addition to notifying the City of the change, A-Tec Upholstery & Body Shop has agreed to honor the past, present and future purchase orders established from contract number FL003007, and

WHEREAS, an emergency exists in the usual daily operation of the Finance and Management Department/ Purchasing Office in that it is immediately necessary to modify contract number FL003007, thereby preserving the public health, peace, property, safety, and welfare, now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBUS:

SECTION 1. That the Finance & Management Director be and is hereby authorized and directed to modify contract FL003007 and all past, present and future purchase orders pursuant to that contract to reflect the change of the company name and FID number from A-Tech Auto Restylin;, FID 311681336 to A-Tec Upholstery & Body Shop, FID 261813154.

SECTION 2. That this modification is in accordance with Section 329.16 of the Columbus City Codes.

SECTION 3. That for the reasons stated in the preamble hereto, which is hereby made a part hereof, this ordinance is hereby declared to be an emergency measure and shall take effect and be in force from and after its passage and approval by the Mayor, or ten days after passage if the Mayor neither approves nor vetoes the same.
