Title: To amend the Management Compensation Plan, Ordinance No. 1150-2007, as amended, by enacting Section 5(E)-E026, the classification of Education Program Supervisor; and Section 5(E)-E193, Enterprise Architect; by amending Section 5(E)-A236, the classification of Assistant Director (Community and Neighborhood Development) (U); Section 5(E)-A231, the classification of Assistant Director (Jobs and Economic Development) (U); and Section 5(E)-H079, the classification of Human Resources Generalist; to repeal Section 5(E)-O034, the classification of Operational Support Division Administrator; and to declare an emergency.

This ordinance amends the Management Compensation Plan by assigning pay grades to the classifications of Education Program Supervisor and Enterprise Architect. The ordinance further recognizes Civil Service Commission action by revising certain classifications and abolishing the classification of Operational Support Division Administrator.

Emergency action is proposed in order for placement efforts to begin.

Any hiring will be funded within the current appropriation.

To amend the Management Compensation Plan, Ordinance No. 1150-2007, as amended, by enacting Section 5(E)-E026, the

classification of Education Program Supervisor; and Section 5(E)-E193, Enterprise Architect; by amending Section 5(E)-A236, the classification of Assistant Director (Community and Neighborhood Development) (U); Section 5(E)-A231, the classification of Assistant Director (Jobs and Economic Development) (U); and Section 5(E)-H079, the classification of Human Resources Generalist; to repeal Section 5(E)-O034, the classification of Operational Support Division Administrator; and to declare an emergency.

WHEREAS, it is necessary to assign pay grades to newly created classifications; and

WHEREAS, it is necessary to recognize further action of the Civil Service Commission by revising and abolishing certain classification titles; and

WHEREAS, an emergency exists in the usual daily operation of the City in that it is immediately necessary to amend the Management Compensation Plan, thereby preserving the public health, peace, property, safety and welfare; Now, Therefore

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBUS:

SECTION 1. That Section 5 of Ordinance No. 1150-2007, as amended, is amended by enacting the following:

SECTION 3. That existing Sections 5(E)-A236, 5(E)-A231, 5(E)-H079, and 5(E)-O034 of Ordinance No. 1150-2007, as amended, are repealed with the passage of this ordinance.

SECTION 4. That for the reasons stated in the preamble hereto, which is hereby made a part hereof, this ordinance is hereby declared to be an emergency measure and shall take effect and be in full force from and after approval by the Mayor, or ten (10) days after passage if the Mayor neither approves nor vetoes the same.
