FISCAL IMPACT: The Ohio Department of Health will reimburse the Health Department a maximum of \$35,000.00 for smoking investigations and the miscellaneous costs incurred from those investigations. The revenue will be deposited into the Health Special Revenue Fund.

<u>BACKGROUND</u>: The Board of Health has been awarded a revenue contract from the Ohio Department of Health in an amount not to exceed \$35,000.00 to conduct investigations of smoking complaints during the period July 1, 2013 through June 30, 2014. Under this contract, the Ohio Department of Health will reimburse the Columbus Health Department for

costs associated with the investigations of smoking complaints filed for violations of Chapter 3794 of the ORC.

To authorize and direct the Board of Health to enter into a revenue contract from the Ohio Department of Health to conduct investigations of smoking complaints, in an amount not to exceed \$35,000.00. (\$35,000.00)

WHEREAS, the Ohio Department of Health has a need for smoking complaints investigations to be conducted on their behalf in accordance with Chapter 3794 of the Ohio Revised Code; and,

WHEREAS, the Ohio Department of Health has contract with the Columbus Health Department to conduct smoking complaints investigations during the period July 1, 2013 through June 30, 2014; Now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBUS:

SECTION 1. That the Board of Health is hereby authorized and directed to into a revenue contract not to exceed \$35,000.00 with the Ohio Department of Health to conduct smoking complaints investigations during the period July 1,
