## BACKGROUND:

The City's Department of Public Service is currently engaged in the Intersection Improvements - Agler Road/Cassady Avenue at Sunbury Road (FRA-CR8-3.67 PID Number 99419) 530086-100033 Public Improvement Project ("Public Project"). The City must acquire certain fee simple title and lesser real estate located in the vicinity of the public right-of-way of Cassady Avenue, Columbus, Ohio 43219 (collectively, "Real Estate") in order for DPS to complete the Public Project. The City passed Ordinance Number 0560-2017 authorizing the City Attorney to acquire the Real Estate. Accordingly, the City intends to appropriate and accept the Real Estate in the event the City Attorney is unable to (i) locate the owners of the Real Estate, or (ii) agree with the owners of the Real Estate in good faith regarding the amount of just compensation.

WHEREAS, the City intends to improve certain public right-of-way by allowing the Department of Public Service (DPS) to engage in the Agler Road/Cassady Avenue at Sunbury Road (FRA-CR8-3.67 PID Number 99419) 530086-100033 Public Improvement Project ("Public Project"); and

WHEREAS, the City intends for the City Attorney to acquire the necessary fee simple title and lesser real estate located in the vicinity of the public right-of-way of Cassady Avenue, Columbus, Ohio 43219 ("Real Estate") in order to complete the Public Project; and

**WHEREAS**, the City intends for the Real Estate's acquisition to help make, improve, or repair certain portions of public roadway and associated appurtenances, which will be open to the public without charge; and

**WHEREAS**, the City intends to appropriate and accept the Real Estate in the event the City Attorney is unable to (i) locate the owners of the Real Estate, or (ii) agree with the owners of the Real Estate in good faith regarding the amount of just compensation; and **now, therefore**,

### **BE IT RESOLVED BY THE COUNCIL OF THE CITY OF COLUMBUS:**

**SECTION 1.** The City, pursuant to the City's Charter, Columbus City Revised Code, Chapter 909 (1959), Constitution of the state of Ohio, and Ohio Revised Code, Chapter 719, declares the necessity and intent to appropriate and accept the fee simple title and lesser real estate to the following listed parcel ("Real Estate"), which is fully described in its associated exhibit and incorporated into this resolution for reference, in order for the Department of Public Service (DPS) to complete the Agler Road/Cassady Avenue at Sunbury Road (FRA-CR8-3.67 PID Number 99419) 530086-100033 Public Improvement Project;

**SECTION 2**. The City Attorney is authorized to cause a written notice of this resolution's adoption to be served in the manner provided by law upon the owner(s), person(s) in possession, or person(s) possessing a real or possible real property interest of record in the Real Estate.

**SECTION 3.** This resolution shall take effect and be in full force and effect from and after the earliest period allowed by law.
