BACKGROUND: The purpose of this legislation is to authorize the Director of Finance and Management to enter into a contract with Hydro Controls, Inc. for the purchase of Golden Anderson Valve Parts. The valve parts are used to maintain the large check valves that control and stop the flow of water being pumped out of the wells.

Approved

The Purchasing Office advertised and solicited competitive bids in accordance with the relevant provisions of City Code Chapter 329 relating to competitive bidding (RFQ006121). Sixty-seven (67) bidders were solicited and two (2) bids were received and opened on July 27, 2017. After a review of the bids, the Division of Water recommends an award be made for all items to Hydro Controls, Inc. in the amount of \$49,574.00 as the lowest, responsive and responsible and best bidder.

The company is not debarred according to the Excluded Party Listing System of the Federal Government or prohibited from being awarded a contract according to the Auditor of State Unresolved Findings for Recovery Certified Search.

WHEREAS, the Purchasing Office opened formal bids on July 27, 2017 for the purchase of Golden Anderson Valve Parts for the Division of Water; and

WHEREAS, the Division of Water recommends an award be made to the lowest, responsive and responsible and best bidder, Hydro Controls, Inc.; and

WHEREAS, the Division of Water will use the Golden Anderson Valve Parts to maintain the large check valves that are used to control and stop the flow of water being pumped out of the wells; and

WHEREAS, it has become necessary in the usual daily operation of the Department of Public Utilities to authorize the Director of Finance and Management to enter into a contract with Hydro Controls, Inc. in accordance with the terms, conditions and specifications of Solicitation Number: RFQ006121 on file in the Purchasing Office; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBUS:

SECTION 1. That the Director of Finance and Management be and is hereby authorized to establish a contract with Hydro Controls, Inc., 473 Cincinnati-Batavia Pk. Suite 2, Cincinnati, OH 45244 for the purchase of Golden Anderson Valve Parts for the Division of Water, in accordance with RFQ006121 specifications on file in the Purchasing Office.

SECTION 2. That the expenditure of \$49,574.00 or as much thereof as may be needed, is hereby authorized in Fund 6000 (Water Operating); in Object Class 02 Materials and Supplies per the accounting codes in the attachment to this ordinance.

SECTION 3. That the funds necessary to carry out the purpose of this ordinance are hereby deemed appropriated, and the City Auditor shall establish such accounting codes as necessary.

SECTION 4. That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.
