WHEREAS, in 1992, John was elected as a judge to the Franklin County Court of Common Pleas, where he served for more than 16 years before being elected to the Tenth District Court of Appeals, where he served until he retired in 2015; and

WHEREAS, he was recognized in his community as the President of the Shamrock Club in 2013, Chair of the Greater Columbus Irish Cultural Foundation, a Clann Na nGael honoree, Columbus St. Patrick's Day Grand Marshal in 2017, Shamrock Club Irishman of the Year in 2006, was an active member of the Charity Newsies throughout his life, and after choosing a life of recovery in December, 2004, helped many others along their journeys; and

WHEREAS, John in survived by daughters, Colleen (John) Williams and Erin (Ed) Winemiller; siblings, Steve, Kathleen Reardon, Jeff, Pete, Leslie Aymes, Mary Hill, Michael, and Suzanne Taggart; grandchildren, Brendan and Paddy Williams, and Eleanor Winemiller; many nieces, nephews, family members, and friends; now, therefore
