### ..Explanation

**BACKGROUND:** This legislation authorizes the Finance and Management Director to renew an existing Universal Term Contract (UTC) for the option to obtain Road and Sewer Maintenance Equipment Parts and Services with The McLean Company. This contract provides for the purchase of Road and Sewer Maintenance Equipment Parts and Services by the Division of Fleet Management to repair City vehicles.

The contract, PO130613, was authorized under Ordinance Number 1790-2018 and will expire August 31, 2020. In accordance with the contract terms, the City and The McLean Company can renew the contract for an additional one year term subject to mutual agreement and approval of proper City Authorities. The new contract expiration date will be August 31, 2021.

**FISCAL IMPACT:** No funding is required to renew the option contract. The Department of Finance and Management, Division of Fleet Management must set aside their own funding for their estimated expenditures.

To authorize the Finance and Management Director to renew a Universal Term Contract for the option to purchase Road and Sewer Maintenance Equipment Parts and Services with The McLean Company.

**WHEREAS**, the Purchasing Office entered into a Universal Term Contract for Road and Sewer Maintenance Equipment Parts and Services for use by the Division of Fleet Management, and

WHEREAS, this contract was entered into in accordance with Chapter 329 of the Columbus City Code, pursuant to Sole Source provisions, and

WHEREAS, in accordance with the contract terms, the City and The McLean Company can renew the contract for an additional one year period, subject to mutual agreement and approval of proper City authorities; and

WHEREAS, it has become necessary in the usual daily operation of the Department of Finance and Management, Division of Fleet Management, to authorize the Finance and Management Director to renew a Universal Term Contract with The McLean Company for the option to obtain Road and Sewer Maintenance Equipment Parts and Services; now, therefore

#### BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBUS:

**SECTION 1.** That the Finance and Management Director is hereby authorized to renew the option contract with The McLean Company, PO130613, for a period of one year, from August 31, 2020 to and including August 31, 2021.

**SECTION 2.** That this ordinance shall take effect and be in force from and after the earliest period allowed by law.
