WHEREAS, the City of Columbus is a participating jurisdiction of the U.S. Department of Housing and Urban Development; and

WHEREAS, the City of Columbus is the recipient of Community Development Block Grant funds from the U.S. Department of Housing and Urban Development; and

WHEREAS, the Columbus City Council has approved the 2023 Action Plan, per Ordinance 3353-2022, as required by HUD; and

WHEREAS, the department advertised a request for proposal for the CHORES Program on Vendor (RFQ023699) from 1/10/2023-2/6/2023. Two proposals were received and both were responsive; and

WHEREAS, the Director of the Department of Development chose to award a Subrecipient Agreement - Not for Profit Service Contract with Rebuilding Together Central Ohio dba Modcon Living in an amount up to \$50,000.00 to administer the CHORES program; and

WHEREAS, Council ordained the provisions of said order on April 3, 2023; and

WHEREAS, the vendor then became non-responsive upon attempting to execute the contract; and

WHEREAS, it is in the City's best interest to repeal Ordinance 0864-2023 and allow the funds to be used for other projects deemed necessary;**NOW, THEREFORE**,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBUS:

SECTION 1. That Ordinance 0864-2023, approved and passed on April 3, 2023 authorizing the appropriation and expenditure of CDBG funds with Rebuilding Together Central Ohio dba Modcon Living the vendor has been non-responsive upon trying to execute the contract.

SECTION 2. That for the reason provided in Section 1, Ordinance 0864-2023 is hereby repealed.

SECTION 3. That this ordinance shall take effect and be in force from and after the earliest period by law.
