This ordinance amends previously adopted ordinance 0666-2024, by increasing the authorized expenditure to a maximum of \$50,000.00. This amendment is necessary to correct a drafting error in the original ordinance.

**WHEREAS**, there is a need to amend previously passed ordinance 0666-2024 because of a drafting error in the original ordinance; and

**WHEREAS**, there is an emergency in the usual daily business of the office of the City Clerk in that it is immediately necessary to amend ordinance 0666-2024 to allow for an increase in the maximum expenditure in time to provide the authorized services; **NOW, THEREFORE**,

## **BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBUS:**

**Columbus City Council** 

**SECTION 1.** That **Section 3** of ordinance 0666-2024 shall be amended as follows:

**SECTION 3.** That per the action authorized in Section 2 of this ordinance, the expenditure of \$35,964.00<u>\$50,000.00</u>, or so much thereof as is needed, is hereby authorized in the Neighborhood Initiatives subfund per the accounting codes in the <u>amended</u> attachment to this ordinance.
