BACKGROUND: This legislation authorizes the Finance and Management Director to establish a Universal Term Contract (UTC) for the option to purchase Police Pursuit Vehicles with Geo. Byers Sons Holding Inc. The Department of Public Safety, Division of Police is the primary user for Police Pursuit Vehicle contract and the contract is used to replace older vehicles within the division. The term of the proposed option contract would be approximately three (3) years, expiring June 30, 2027, with the option to renew for one (1) additional year. The Purchasing Office opened formal bids on March 7, 2024. In addition, the expenditure of \$1.00 is hereby authorized from General Budget Reservation BRPO002726.

The Purchasing Office advertised and solicited competitive bids in accordance with the relevant provisions of Section 329 relating to competitive bidding (Request for Quotation No. RFQ026902. Two (2) bids were received.

The Purchasing Office is recommending award to the overall lowest, responsive, responsible and best bidder as follows:

Geo. Byers Sons Holding Inc., CC# 006008, expires 3/13/2026, All Items, \$1.00 Total Estimated Annual Expenditure: \$4,500,000.00, Division of Police, the primary user

The company is not debarred according to the Excluded Party Listing System of the Federal Government or prohibited from being awarded a contract according to the Auditor of State Unresolved Findings for Recovery Certified Search.

FISCAL IMPACT: The expenditure of \$1.00 is hereby authorized from General Budget Reservation BRPO002726. City Agencies will be required to obtain approval to expend from their own appropriations for their estimated annual expenditures.

WHEREAS, the Police Pursuit Vehicles UTC will provide for the purchase of Police Pursuit Vehicles to replace older, higher maintenance Police Pursuit vehicles within the division; and,

WHEREAS, the Purchasing Office advertised and solicited formal bids on March 7, 2024 and selected the overall lowest, responsible and best bidder; and

WHEREAS, it has become necessary in the daily operation of the Department of Public Safety, Division of Police to authorize the Director of Finance and Management to enter into a Universal Term Contract for the option to purchase Police Pursuit Vehicles; **now, therefore**

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBUS:

SECTION 1. That the Finance and Management Director is hereby authorized to enter into the following Universal Term Contract for the option to purchase Police Pursuit Vehicles in accordance with Request for Quotation RFQ026902 for a term of approximately three (3) years, expiring June 30, 2027, with the option to renew for one (1) additional year, as follows:

Geo. Byers Sons Holding Inc., All Items, \$1.00

SECTION 2. That the expenditure of \$1.00 is hereby authorized from General Budget Reservation BRPO002726 of this ordinance to pay the cost thereof.

SECTION 3. That the funds necessary to carry out the purpose of this ordinance are hereby deemed appropriated, and the City Auditor shall establish such accounting codes as necessary.

SECTION 4. That this ordinance shall take effect and be in force from and after the earliest period allowed by law.
